<u>Payment Schedule</u> - The annual prepay option is arranged through the ACS office (due by July 20th). The 10 monthly payments (August – May) are arranged through FACTS Management Company (5th or 20th of each month). **Please set up OR update your account at the following online address: online.factsmgt.com/signin/3X94J.**

<u>Late Tuition Policy</u> – Although FACTS Management Company specifies the date each payment will occur, it is the responsible party's financial institution that determines the time of day the payment is debited to the account. A missed payment fee will be automatically assessed by FACTS from the responsible party's account for each payment attempt that is missed. If these fees are missed, they also will be re-attempted. In addition, the financial institution may assess its own NSF fee. Any account past due by 90 days will necessitate the removal of the student from the school unless the responsible party presents a payment plan for approval to the Financial Committee of the ACS Board of Education.

<u>Early Withdrawal Policy</u> – If a student is withdrawn during the school year, charges are paid according to the actual number of days attended, plus 10% of the unpaid portion of the year's tuition.
